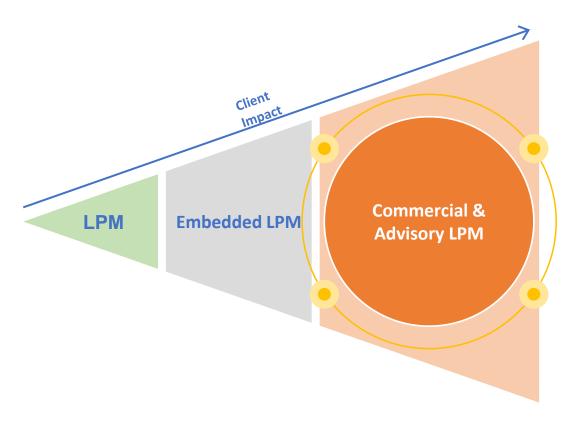

Advice on Legal Project Management & Legal Operations



August - November 2021

Legal Operations secondment to Outside Counsel Management (OCM) team reporting to COO/John Burke (remote/part-time) to focus on **UBS LPM development**

February 2022

Legal Operations collaborated with OCM team to create a **bespoke Design**Thinking workshop series for COO team

March 2022

Follow up **Design Thinking session** rewritten and attended by nearly **200 UBS lawyers** across the global GGC team

From May 2022

Exploratory LPM meetings between UBS and HSF Legal Operations & LPM experts including HSF Legal Project Managers in Australia and Asia

July 2022

Proposal submitted to OCM for flexible access to LPM & Legal Operations experts to support UBS LPM approach

September 2022

Embedded LPM support begins with focus on budget certainty and commercial optimization on key strategic matters

January 2023

Demonstration and implementation of **Client portal dashboards**

From October 2022

Idea sharing as part of discussions with the UBS Legal Project Manager for HSF to support the development of a **UBS LPM strategy** building on outputs generated as part of support for the UBS LPM approach

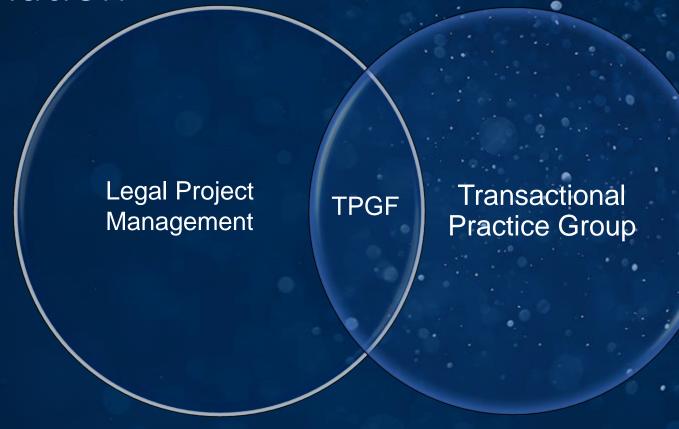

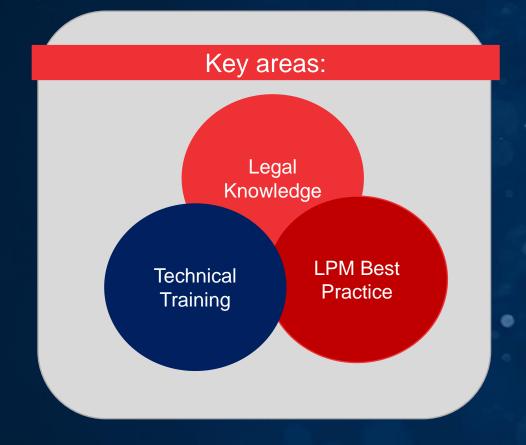
Transactional Practice Group at Baker McKenzie

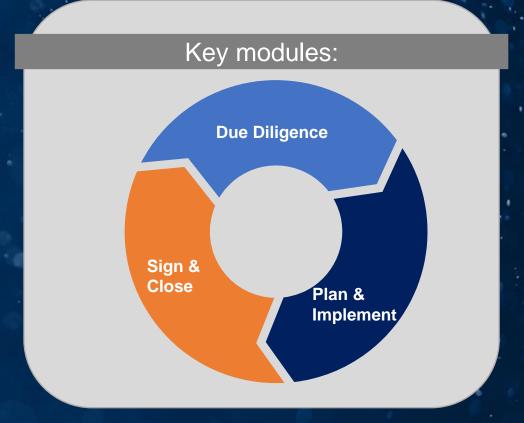


Transactional Practice Group Focus Formation

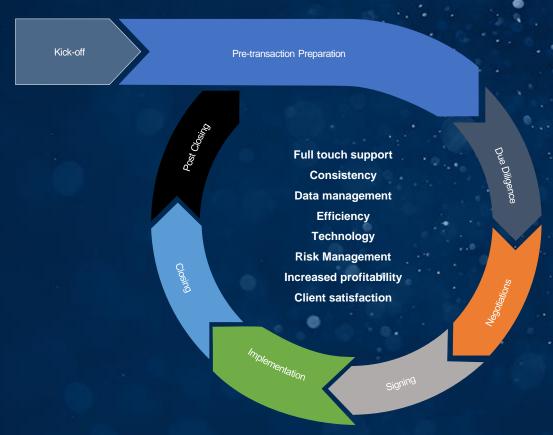


Transactional Practice Group Focus Training

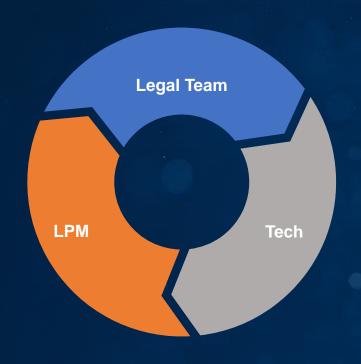
